Arroyo Hondo Arriba Land Grant hosts Committee meeting

The Arroyo Hondo Arriba Land Grant hosted the most recent Land Grant Interim Committee meeting in Taos on August 18-19. The initial meeting took place at UNM Taos where the land grant board of trustees spoke to legislators about the history of their land grant and newly developed concerns regarding the well-being of their watershed. Youth mentees and youth development coordinators from the NMLGC, NMAA and the Cerro Negro Project also presented to the Committee.

The next day, legislators were given a tour of the land grant, former *escuelita* and remodeled *morada*. Community members were invited to speak of their lived experiences in Valdez and current struggles being faced by the land grant and surrounding communities.
