## Cañon de Carnué Land Grant hosts latest Interim hearing



The Cañon de Carnué Land Grant hosted the latest Land Grant Interim Committee hearing on October 23 and 24. Presidents and board members from the Town of Tomé, Cañon de Carnué, Chililí, and Manzano Land Grants presented the most recent accomplishments and immediate needs of their land grants. The Town of Tomé Land Grant recently purchased agricultural land in production, in hopes that they can teach youth in the community traditional agricultural methods. They are hoping to purchase more land with a capital outlay award received during the latest legislative session in an effort of conserve these lands for agricultural use. Juan Sánchez (La Merced de Pueblo de Chililí) shared the land grant's vision to expand its affordable housing project, allowing its heirs to remain in the community.

Andrea Padilla, President of the Land Grant-Merced Consejo, updated the Committee on the most recent accomplishments collectively achieved by land grant-mercedes. These accomplishments include acquiring properties and buildings to service land grant communities and several large-scale fuelwood projects that provide communities with firewood for the winter. Committee members also heard updates from Steve Polaco (La Merced de los Pueblos de Tierra Amarilla) and Leonard Martinez (La Merced de San Joaquin del Río de Chama) regarding the Mercedes Unidas Visitor's Center, previously the Piedra Lumbre Visitor's Center. They shared their need for additional funding to complete all the necessary renovations and their hopes for creating economic opportunities for these northern land grant communities on this property.

Legislators were given a tour the following day of the common lands and campsite operated by the Cañon de Carnué Land Grant. Committee members were also given a tour of La Merced del Manzano's community center and its lake, operated by the land grant. This campsite and lake were both worksites for the Ancestral Land Conservation Corps youth group during the summer of 2022.
